

CONDITIONS OF ENTRY & LIMITATIONS OF LIABILITY

1. You enter and use this car park at your own risk.
2. Entry to this car park is only available via:
 - (a) a casual ticket received prior to entry;
 - (b) a pre-paid ticket; or
 - (c) a pass card issued to you by Canberra Airport.
3. Any exit without a valid and paid ticket or pass card may result in additional parking and administration fees being levied against you.
4. We are not liable for you or any person with you for:
 - (a) injury to you or anybody else;
 - (b) damage to, destruction of, theft of or unauthorised delivery up of your vehicle or any other vehicle whether authorised or not; or
 - (c) damage to, destruction of, theft of or delivery up of any property (Including anything in or on your vehicle or any other vehicle); however caused, and you release and indemnify us from any claim, which you might otherwise have against us.
5. You agree to indemnify us in respect of any claim made against us as a consequence of, in relation to, or in any way arising out of the use of this car park.
6. We will not be liable to you for delivery of your vehicle to any person who did not have authority to take your vehicle.
7. Infringement notices distributed for illegal parking in this car park are enforceable under contract law and local council by-laws.
8. A parking fee is payable each time a vehicle enters here. If you bring a vehicle into this car park you agree to pay the parking fee as set by us from time to time. We may prevent the exit of a vehicle from this car park until the fee is paid and we are not liable from preventing the exit of a vehicle until the fee is paid or for any injury, damage or loss which results.
9. We have a general lien, and the right to retain your vehicle as a security for any money which you owe us.
10. You agree to:
 - (a) produce and display when requested by us, your valid parking ticket or pass card as proof of payment of the parking fee;
 - (b) not to cause any obstruction;
 - (c) not to park anywhere that we designate as a no parking area; and
 - (d) not to use this car park other than in accordance with instructions that an authorised officer may give.
11. We have the right, at our discretion, to move or immobilise any vehicle, (including moving it to any location outside this car park), even if your vehicle is locked. If we move your vehicle, these conditions continue to apply. We are not liable for any damage caused to your vehicle when we move it.
12. These conditions may only be altered by a written agreement between you and us.
13. If any of these conditions are illegal or unenforceable, the offending part is to be disregarded and does not affect the remaining part.
14. Each exclusion of our liability in these conditions is subject to any law which restricts or forbids that exclusion of liability including the Trade Practices Act and similar State or Federal legislation.
15. Bicycle storage is to be used at your own risk. We will not accept responsibility for any lost, stolen or damaged bicycles.
16. In these conditions references to:
 - (a) "we", "us" and "our" mean Canberra Airport, ABN 14 080 361 548, its employees, agents and independent contractors or both; and
 - (b) "your vehicle" includes a vehicle driven, or intended to be driven by you into the car park.
17. No overnight parking is allowed in Brindabella Business Park.
